level stream, specialist areas, as well as other accounting and finance-related professional and


academic skills, may be used to assess a person's financial literacy level. Business management

Respondents were required to complete a series of multiple choice questions on financial products in order to get access to the financial literacy assessment. According to table 1, there were a total of 18 questions posed.



Individuals were categorised into three groups based on the number of accurate answers they provided in a financial literacy test: high (more than 12), average (7-12), and poor (up to 6 correct answers). Table 2 contains information on the financial literacy of the survey participants. More over half (N=240, 47.06%) of respondents had a high degree of financial literacy, whereas only 41.76 percent (N=213) had an average level of financial knowledge.
